| Description and Uses Summary   | <p>This map shows the land tenure classes for the region and breaks reserve tenure into its categories (according to the CAR reserve layer). Informal reserves are not shown. Areas for reserve categories are regarded as accurate as shown. Areas for reserves and broad tenure categories have been rounded. Land parcels that are owned by the Aboriginal Land Council of Tasmania but are listed as a private parcel (CAD_Type) in LIST Parcels may not display as Aboriginal Land on the map. The same limitations apply as for Map 1 (e.g. total areas will vary according to which dataset is used, and what coastline and estuaries are included).
